"We as local government, we have to ensure that the dialogue between communities and professionals has a spirit of equality, knowing that the population is well informed about their rights and duties. I personally have no doubt that the project will help promote this engagement and help overcome some chronicle problems of poor health care in our hospitals."

Eduardo Assane Ali, district administrator of Muembe district: "At first we accepted the project but with many reservations because we had no idea about how this thing of social accountability works in practice. But after two years of joint work between the government and the civic group we learned this project brought an innovation - new tool for achieving the government main objective - participatory district governance. Today we can say that the project helped us to strengthen the ongoing communication between health workers and communities as well as to understand what we need to improve. Health auditoriums are new to us and have proved to be an important space the government, civil society and district development partners sit at the same table for a joint reflection and take some corrective actions".

As a member of the civic group and the participant in the training I have learned about my rights and duties as a citizen and as a user. I encourage women in my village to approach the midwives and give them advice on how to better receive women who seek the assistance in the health centre."

João Júlio Manguinja, district administrator of Maúa district, after the first auditorium in Maúa said that "the report presented during Public Auditorium brings about the real concerns of our communities. The civic group is the link, is the lobby group that is reminding government that it has to fulfil its promises. We commit ourselves to do everything we can to improve the health of communities. This event was a big learning process for us and we want to appeal to health professionals to accept the recommendations, appeal to civil society to continue to sensitize communities about their rights and responsibilities, with emphases on constructive collaboration mechanisms with the sector and dissemination of bad practices to help with behaviour changes. The government has shown openness to dialogue and most importantly, agreed to deal with the issues raised and accepted the recommendations. One of the issues that civic groups raised was the distance that separates them from reference health facilities. I found very positive the government's response and commitment to a construction of a health unit closer to communities. We should be more aware of the values and responsibilities that each of us have and make joint efforts to achieve satisfactory results in health care. We, the media, have an important role in dissemination of strategies, mechanisms and relevant information of the health sector..."
